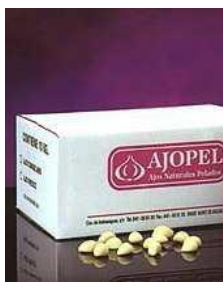
How to use the frozen product:

Remove from freezer, remove the required quantity and return to the freezer. Do not break the cold chain.

How to use the defrosted product and storage guidelines:

Thaw in refrigerated conditions for the necessary time. Once the product has been defrosted, re-store in the sealed container at a temperature of 0-4°C for up to 7 days.
